
The Union proposes the following language:


Relocation Support Payment

- A. CDCR and CCHCS permanent employees at California City Correctional Facility (CAC), and CCHCS employees at California Men's Colony (CMC) who relocate their residence more than fifty (50) miles as a result of participating in the Voluntary Transfer Process (VTP) related to the closure of CAC and the yard deactivation of CMC, shall receive a one-time payment related to the relocation in the amount of \$1,500.
- B. This agreement expires June 30, 2024.


